According to the Directive on procurement in Diplomatic Missions and Consular Posts of the Republic of Serbia No. 716/GS dated 20 May 2013 and Instructions on Conducting Procurement in DCMs of the Republic of Serbia Abroad No. 716-2/GS dated 3 July 2013, the Embassy of the Republic of Serbia in Beijing announces

**DECISION ON ABANDONMENT of the PROCUREMENT PROCEDURE  
of high value works**

**Design and execution of construction works to alter the structural concept of the building for the purposes of the Culture Center of the Republic of Serbia in Beijing, People's Republic of China  
Serial No. 81-3/2018**

This to state that the procurement procedure of high value works Design and execution of construction works to alter the structural concept of the building for the purposes of the Culture Center of the Republic of Serbia in Beijing, People's Republic of China Serial No. 81-3/2018 has been abandoned

**E x p l a n a t i o n**

The procurement procedure has been abandoned in the phase of expiration of deadline for submitting the bids, opening the bids and the process of negotiation thereafter

The reason for abandoning the herein procurement procedure is that the only one bid that has been submitted in the process of procurement has been assessed as unacceptable.

The Contracting Authority has commenced the procurement procedure of high value work on 28 February 2018 by Decision on commencing the procedure No. 81/2018

The invitation bid and tender documentation have been posted on the webpage of the Embassy on 2<sup>nd</sup> March 2018

After conducted procedure of bids opening and composing of the Minutes of bids opening No. 103 dated 12 March 2018, the Procurement Committee has entered the process of bids evaluation and consequently have made Assessment Report No. 103-2/2018 dated 14 March 2018

In the Assessment Report, the Committee has concluded the following:

- **Subject of procurement and assessed procurement value**

Subject of procurement are the works: design the main project and execution of construction works

**The procedure of opening of bids has been conducted in the premises of the Embassy of the Republic of Serbia in Beijing, at the address Sanlintun Dong Liu Jie No.1 on 12 March 2018 at 15.00. The Minutes of opening bids has been made thereafter.**

- The estimated value of the procurement amounts 8.333.000,00 RSD (excluding VAT) that is 552.220,02 CNY respectively

- Financing for herein procurement amounting 5.000.000 RSD has been provided by the Law on the budget of the Republic of Serbia for 2017. (RS Official Gazette No.99/16), within the slot 27 – function 820, Program 1205 YIA 0006, economic classification 424 – Specialization of services and 5.000.000 RSD based on the requirements for allocation of funds from the current budget reserves 401-01-450/2017-06
- Bidders that have participated in the procedure

There has been no representative of bidders  
 There has been no other parties

- **There has been no untimely bids**
- **The rejected bids, reasons for rejection of bids and offered price of those bids**

Reasons for rejecting the bid:

Value - price of the received bid amounts 600.519,82 CNY (excluding VAT) that is 9.061.844,09 RSD on the day of bids opening

Submitted bid is rejected as unacceptable by reason of its failure to meet the following requirements from the Tender documentation:

The bid does not contain required bank guarantee, statement of number of employees and filled contract. Besides, submitted company introduction is in Chinese language – it is not translated into English hence its content cannot be proved.

The Committee has stated that offered price is higher from estimated price (for 728.844,09 RSD excluding VAT, that amounts 48.299,81 CNY)

- **Awarding Contract criteria:**

Criteria for contract awarding is the lowest offered price.

- **Ranking list adequate and acceptable bids by applying the awarding contract criteria**

The Procurement Committee has stated that in the procedure of herein procurement has been no acceptable offers.

- **Proposal of the Procurement Committee**

The Procurement Committee states that in the process of procurement of high value works Design and execution of construction works to alter the structural concept of the building for the purposes of the Culture Center of the Republic of Serbia in Beijing, People's Republic of China Serial No. 81-3/2018, no conditions have been created for contract awarding, therefore proposes Contract Authority to abandon herein procedure and repeat it thereafter.

Based on the above, the decision was deemed a final judgment
